



Diamond Hill Funds Year-To-Date Capital Gains

All mutual funds must distribute to shareholders any net realized gains from the sale of individual securities in their portfolio. As a service to our mutual fund shareholders, Diamond Hill is communicating year-to-date realized capital gains for all of our mutual funds. Our communication includes each Fund's total per share factor of short term and long term realized gains and the total of these two figures as a percent of each Fund's net assets.

These figures reflect actual year-to-date undistributed realized gains through September 30, 2018. It is important to remember that these are not estimates of the final year-end fund distribution figures. Because actual distributions will not be determined until October 31, 2018, it is impossible to estimate year-end distributions until the end of October. Capital gain estimates will be published in mid to late November. Distributions, whether reinvested or not, will be subject to federal and possible state income tax unless shares are held in a tax-free or tax-deferred retirement account. The per-share amount of the undistributed realized gain will be identical for all share classes.
